# **Delivery**

Parseport ApS will begin processing your task as soon as possible after it has been received. The timeframe of when you can expect to receive the XBRL file depends on the kind of file, you submit.

If you have submitted a class B account, you can expect to have the files returned within 24 working-hours.

If you have submitted a class C (both medium and large) account, you can expect to have the files returned within 72 working-hours.

If you have submitted an IFRS financial statement, you can expect to have it returned within one week.

However, during our prime season from April to June, we do ask for patience.

The payment shall be made in advance, by credit card, through ParsePort's website at the time of a DK GAAP service request submission to ParsePort.
